

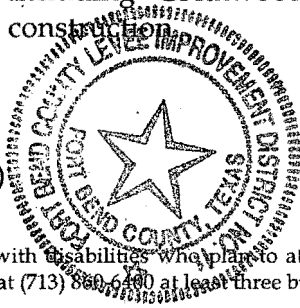
NOTICE OF MEETING


FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 11

The Board of Directors of Fort Bend County Levee Improvement District No. 11 will hold a regular meeting on **Tuesday, December 3, 2013, at 5:00 p.m.**, at the offices of Mike Stone Associates, Inc., 19875 Southwest Freeway, Second Floor, Suite 270, Sugar Land, Texas, to discuss and, if appropriate, act upon the following items:

1. Minutes of prior meeting(s).
2. Comments and questions from the public.
3. Gen Max, Grid Reliability Program Presentation from Acclaim Energy Advisors.
4. Travel Reimbursement Guidelines and Director Expenses for Association of Water Board Directors winter conference.
5. Financial and bookkeeping matters, including payment of the bills, review of investments, and budget comparison.
6. Authorize preparation of Annual Report in accordance with District's Continuing Disclosure of Information Agreement and as required by SEC Rule 15c2-12.
7. Tax assessment and collections matters, including payment of tax bills, delinquent tax collections, and installment agreements.
8. Operation of District facilities, facilities inspection, repairs and maintenance, and execution of any letters regarding unauthorized use of levee or drainage facilities and imposition of fine.
9. Levee and ditch mowing.
10. Update from District's architect regarding design of emergency operations building.
11. Engineering matters, including:
 - a. emergency operations building, replat of property, relocation of CenterPoint Energy poles, and proposal for vertical inspections;
 - b. deeds, easements, consents to encroachment, or plats;
 - c. development within or affecting the District; and
 - d. agreement or easement to Fort Bend County Municipal Utility District No. 106 or the City of Sugar Land for use of lake for non-potable water storage and assignment of water rights permit coordinating with the City of Sugar Land regarding the matter.
12. Phase II MS4 Storm Water Management Plan implementation.
13. Emergency Preparedness Committee matters.
14. Community Projects Committee, including public parks and Holiday Open House.
15. Fort Bend Flood Management Association matters/actions, Federal flood insurance legislation, perimeter levee maintenance, and attendance at levee conferences.
16. Reports from Directors and consultants on Greatwood President's meeting and activities and follow up during the month on levee and drainage facilities and other District and Greatwood regional matters, including Greatwood Districts' articles and information for website correspondence regarding construction.
