


NOTICE OF MEETING

FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 11

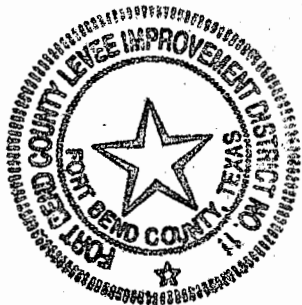
The Board of Directors of Fort Bend County Levee Improvement District No. 11 will hold a regular meeting on Monday, August 1, 2016, at 5:30 p.m., at **Independent Bank, 19855 Southwest Freeway, Suite 100, Sugar Land, Texas**, to discuss and, if appropriate, act upon the following items:

1. Minutes of prior meeting(s).
2. Comments and questions from the public.
3. Tax assessment and collections matters, including payment of tax bills, delinquent tax collections, and installment agreements.
4. Financial and bookkeeping matters, including payment of the bills, review of investments, budget comparison, and adopt budget for fiscal year end September 30, 2017.
5. Levee and ditch mowing including:
 - a. drainage channel clean out;
 - b. mosquito treatment;
 - c. turf maintenance matters;
 - d. redundant levee mowing and weed eating; and
 - e. authorize proposals to be solicited by the District's engineer for new contract, if appropriate.
6. Operation of District facilities including:
 - a. facilities inspection, repairs and maintenance and emergency operations;
 - b. water levels in main lakes;
 - c. inspection report on outfall 2 gabion baskets; and
 - d. execution of any letters regarding unauthorized use of levee or drainage facilities and imposition of fine.
7. Engineering matters, including:
 - a. deeds, easements, consents to encroachment, or plats;
 - b. development within or affecting the District;
 - c. review bids and award contract for installation of fencing to prevent unauthorized access;
 - d. discuss capital improvement plan, engineering design, and bond application no. 4; and
 - e. acquisition of property from Canyon Gate Homeowners association and approve Special Warranty Deed, if appropriate.
8. Phase II MS4 Storm Water Management Plan implementation.
9. Community Projects Committee.
10. Reports from Directors and consultants on Greatwood Presidents' meeting and activities and follow up during the month on levee and drainage facilities and

- other District and Greatwood regional matters, including Greatwood Districts' articles and information for website.
11. Federal flood insurance legislation, perimeter levee maintenance, and attendance at levee or floodplain conferences.
 12. Attorney's report.
 13. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney to discuss pending or contemplated litigation filed against the District by the Texas Department of Transportation, or a settlement offer.
 14. Reconvene in Open Session and authorize appropriate action regarding contemplated litigation filed against the District by the Texas Department of Transportation, or a settlement offer.
 15. Convene in Executive Session pursuant to Section 551.072, Texas Government Code, to deliberate the purchase, exchange, lease, or value of real property.
 16. Reconvene in Open Session and authorize appropriate action regarding the purchase, exchange, lease, or value of real property.
