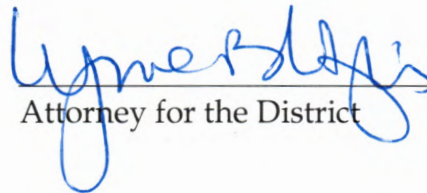
FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 11

The Board of Directors of Fort Bend County Levee Improvement District No. 11 will hold a regular meeting on **Monday, March 4, 2019, at 5:00 p.m.**, at the **Greatwood Community Association Building, 7225 Greatwood Parkway, Sugar Land, Texas**, to discuss and, if appropriate, act upon the following items:

1. Minutes of prior meeting(s).
2. Public comments (each member of the public is allotted 3 minutes).
3. Tax assessment and collection matters, including payment of tax bills, delinquent tax collections, and installment agreements.
4. Financial and bookkeeping matters, including payment of the bills, review of investments and budget comparison.
5. Order Adopting Amended and Restated Procedures for Continuing Disclosure Compliance.
6. Levee and ditch mowing.
7. Operation of District facilities including:
 - a. facilities inspection, repairs and maintenance and emergency operations;
 - b. security cameras at pump stations; and
 - c. execution of any letters regarding unauthorized use of levee or drainage facilities and imposition of fine.
8. Engineering matters, including design, plans and specifications and authorize advertisement for bids, review bids and award contract, pay estimate, change order, and final acceptance for the following projects:
 - a. capital improvement plan and design of improvements in the bond application;
 - b. detention pond capacity increase and levee raising project;
 - c. back up sluice gates at Pump Station No. 1 and Pump Station No. 2;
 - d. storm water pump station at Forest Green; and
 - e. evacuation analysis.
9. Acquisition of property for levee raising project and engage Hunton Andrews Kurth LLP to provide condemnation services.
10. MS4 Storm Water Management Plan, including public comments and approve Year 5 Annual Report.
11. Website matters.
12. Attorney's report, including:
 - a. annual Report and authorization to file same with appropriate information depositories in accordance with District's Continuing Disclosure of Information Agreement as required by SEC Rule 15c2-12; and

16. Convene in Executive Session pursuant to Section 551.076, Texas Government Code, to deliberate the deployment, or specific occasions for implementation of security personnel or devices, or a security audit.
17. Reconvene in Open Session and authorize appropriate action regarding deployment, or specific occasions for implementation of security personnel or devices.
18. Convene in Executive Session pursuant to Section 551.072, Texas Government Code, to deliberate the purchase, exchange, lease, or value of real property.
19. Reconvene in Open Session and authorize appropriate action regarding the purchase, exchange, lease, or value of real property.
