

## NOTICE OF MEETING


### FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 11

The Board of Directors of Fort Bend County Levee Improvement District No. 11 will hold a regular meeting on Tuesday, July 26, 2011, at 2:30 p.m., at Professional Project Management Services, 19875 Southwest Freeway, Second Floor, Suite 270, Sugar Land, Texas, to discuss and, if appropriate, act upon the following items:

1. Minutes of prior meeting(s).
2. Comments and questions from the public.
3. Meeting Room Rental Agreement with Professional Project Management Services.
4. Financial and bookkeeping matters, including payment of the bills, review of investments, and budget comparison.
5. Tax assessment and collections matters, including payment of tax bills, delinquent tax collections, and installment agreements.
6. Resolution Voting for Water District Nominee for the Election of the Board of Directors of the Fort Bend Central Appraisal District.
7. Phase II MS4 Storm Water Management Plan implementation.
8. Operation of District facilities, including repairs and maintenance, landscaping at cul-de-sacs by Greatwood Community Association to prevent access to levee and execution of any letters regarding unauthorized use of levee or drainage facilities and imposition of fines.
9. Engineering matters, including:
  - a. design of retaining wall erosion repair at large detention pond and approval of plans and specifications and authorization to advertise for bids;
  - b. design of emergency operations building;
  - c. Fort Bend Drainage District criteria and Public Hearing on July 18, 2011;
  - d. deeds, easements, consents to encroachment, or plats;
  - e. development within or affecting the District;
  - f. annexation requests and agreements; and
  - g. proposal from T-Mobile for installation of antenna.
10. Disaster Preparedness Committee matters, including adopt Amended Emergency Preparedness Plan and Amended Resolution Regarding Delegation of Authority in Emergencies.
11. Community Projects Committee and possible park improvements and website survey.
12. Fort Bend Flood Management Association matters/actions, Federal flood insurance legislation, and attendance at levee conferences.
13. \$3,230,000 Unlimited Tax Levee Improvement Bonds, Series 2011, including:
  - a. appoint Paying Agent/Registrar;
  - b. appoint Escrow Agent;
  - c. adopt Resolution Authorizing Application to the Texas Commission on Environmental Quality Requesting Waiver of Requirement to (or Release of) Escrow Funds;
  - d. approve Preliminary Official Statement and Official Notice of Sale; and
  - e. authorize advertisement for sale of the Series 2011 Bonds and schedule bond sale.

14. Reports from Directors and consultants on Greatwood President's meeting and activities and follow up during the month on levee and drainage facilities and other District and Greatwood regional matters, including Greatwood Districts' articles and information for website.
